# MEMBERSHIP APPLICATION, RELEASE & RULES

Welcome to Twin Rivers! Here are just a few simple rules that will help keep you safe and allow everyone to enjoy the benefits of this facility!

1. Let us know when you are coming. 24 hour notice is REQUIRED \_\_\_\_\_ initial here
2. The Covered Arena is private and not open to public use. \_\_\_\_\_ initial here
3. Sign in and pay BEFORE you ride. Members can skip this step as long as you let us know you were coming! (Current certificates are acceptable, limit \$60 value per day) \_\_\_\_\_ initial here
4. Read the signs to see if any arenas or XC jumps are closed. Or ask us. Please respect the closed areas. \_\_\_\_\_ initial here
5. No lunging/rolling in any of the main arenas. The lunging arena is for this purpose. \_\_\_\_\_ initial here
6. Helmets are required for any mounted activity. Safety vests are required for any XC jumping. We have loaners available. \_\_\_\_\_ initial here
7. No jumping alone. Please have someone with you for any type of jumping. \_\_\_\_\_ initial here
8. Leave all jumps as you find them. Do not take any poles or standards to the XC without first asking us. You must return them when finished. \_\_\_\_\_ initial here
9. The stalls and paddocks are \$40 per day to use. DO NOT TIE TO BARNs \_\_\_\_\_ initial here
10. Keep your dogs on a leash. We have chickens, small dogs, cats, and kids that live here, so please respect our space. Do not leave dogs unattended in stalls \_\_\_\_\_ initial here
11. If you or your horse causes unusual damage to any of our property, you will be asked to reimburse us for it. Your use fees do NOT cover damaged stalls or broken jumps. \_\_\_\_\_ initial here
12. \$50 late fee if you have not paid BEFORE leaving the property. \_\_\_\_\_ initial here
